1. Qualification Information

1.1 About the qualification

The qualification has been approved by the Office of Qualifications and Examinations Regulation (Ofgual) that regulates qualifications, examinations and assessments in England.

The Gateway Qualifications Level 3 Award in Information, Advice or Guidance aims to provide learners with the skills and underpinning knowledge required by employers in a broad range of contexts where information, advice or guidance is provided.

The qualification is appropriate for learners who have responsibility for information, advice or guidance as part of their core work and for those who may be involved in general signposting within the sector. The qualification will also support work based learning within the sector. The qualification is appropriate to those working in Further Education supporting young people with careers and personal choices such as teachers, lecturers, support staff and learning mentors. It is also appropriate to those giving advice in the Voluntary Sector, health workers and anyone who would benefit from a programme of study reinforcing good practice, underpinning knowledge and formally recognising learning and skills developed through experience.

The qualification is particularly suitable for those who:

- have completed another qualification at Level 2 in a relevant occupational sector
- deliver information, advice or guidance and who want recognition for the work that they do
- are Personal Advisors in the Welfare to Work sector who may need to develop their skills in providing personalised support.

1.5 Achievement methodology

The qualification will be awarded to learners who successfully achieve the mandatory units through a Portfolio of Evidence that has been successfully verified and monitored through Gateway Qualifications' Quality Assurance process. Achievement is therefore determined by successful completion of unit assessment with no further requirement for additional/summative assessment.

2. Learner Entry Requirements

2.1 Age

The approved age range for these qualifications is: 19+

2.2 Prior Qualifications

There is no requirement for learners to have achieved prior qualifications.

2.3 Prior skills/knowledge/understanding

The demands and nature of the qualification and the assessment requirements are such that learners will need to have literacy skills which are a least at Level 2 of the National Standards in Adult Literacy. To meet this requirement, learners may achieve Functional Skills at Level 2 in English which aligns with the Level 2 Adult Literacy Standards. This level is required in all three skill areas of literacy.

The learner will need to be able to:

- Read and interpret given tasks
- Provide answers that are clear, logical and understandable
- Organise relevant information clearly and coherently.

Learners will also need to have a minimum level of experience in the delivery of information, advice or guidance.

2.4 Restrictions

There are no other restrictions to entry.

2.5 Access to qualifications for learners with disabilities or specific needs

3.1 Recognition of Prior Learning (RPL)
