## 1. Qualification Information

### 1.1 About the qualifications

---

The qualifications have been approved by the Office of Qualifications and Examinations Regulation (Ofqual) that regulates qualifications, examinations and assessments in England.

The Gateway Qualifications Level 2 Certificate in Garden Design has been designed to enable learners to develop the underpinning plant knowledge and drawing skills required to enter the garden design industry.

The Gateway Qualifications Level 3 Certificate in Garden Design has been designed to enable learners to develop the drawing skills and the plant knowledge required to enter the garden design industry.

The Level 2 and 3 Certificate qualifications can be used in conjunction with other horticultural qualifications for those new to the land based sector.

Achievement of the Gateway Qualifications Level 3 Certificate in Garden Design meets the minimum required standard for occupational competence to function as a professionally competent garden designer.

The Gateway Qualifications Level 3 Certificate in Plants and Planting Design has been designed to enable learners to develop specialist knowledge and skills in readiness for setting up a planting design business.

The Gateway Qualifications Level 3 Certificate in the Principles and Practice of Garden Design has been designed to enable learners to develop specialist knowledge and skills in readiness for employment as part of a garden design practice or larger organisation such as a local authority, or in setting up a self-employed business in design and structure.

The Gateway Qualifications Level 3 Diploma in Garden Design has been designed to enable learners to develop design skills and knowledge of both plant requirements and garden design solutions required within the garden design industry. Achievement of this qualification meets the required standard for occupational competence to function as a professionally competent garden designer and, in addition, enables the learner to develop the additional business and customer service skills required to run a successful garden design business. On completion of this qualification learners will be equipped to progress to employment within the garden design industry.

The qualifications have been designed in conjunction with the garden design specialists at Capel Manor College.

### 3.3 Recognition of Prior Learning (RPL)
